

## Privacy Collection Statement

DDB Worldwide Pty Ltd (ABN 89 004 387 599) and its operating subsidiary Track Customer Marketing Pty Ltd (ABN 50 071 949 061) collect personal information about you from <http://www.ddb.com.au>, [www.track-au.com](http://www.track-au.com) and any related DDB or client website, social media page, internal website or intranet and any DDB or client mobile or tablet application (each, a **Website**); personal information provided to us by our clients and customers; personal information collected by us on behalf of our clients and customers as a result of the provision of professional services to our clients and customers, and; as provided by you by any other means, including either physically or electronically. Our Websites may also collect and use passively collected anonymous information or personal information from various third party sources and may combine this anonymous information or personal information with other personal information collected from you, to provide better service to Website users, customise a Website based on your preferences, compile and analyse statistics and trends, administer and improve our Websites for your use, and to provide you with targeted advertising when you browse third party websites. For the purposes described above, your information may be shared with DDB group companies (and their directors, servants and agents), promotional partners and other trusted third parties including our service providers, either in Australia or overseas including New Zealand, Singapore, countries in the Asia Pacific region, the United Kingdom and the United States of America.
